### FOURTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

OF

### ENDURANCE REINSURANCE CORPORATION OF AMERICA

Endurance Reinsurance Corporation of America, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

- 1. The Corporation was formed in Delaware under the name Endurance Reinsurance Company of America on March 15, 2007. A First Amended and Restated Certificate of Incorporation of the Corporation was filed on December 13, 2007, a Second Amended and Restated Certificate of Incorporation of the Corporation was filed on January 30, 2008, to effect the merger of Endurance Reinsurance Corporation of America into the Corporation, and to change the name of the Corporation from Endurance Reinsurance Company of America to Endurance Reinsurance Corporation of America and a Third Amended and Restated Certificate of Incorporation of the Corporation was filed on December 21, 2010.
- 2. Pursuant to Sections 242 and 245 of the General Corporation Law of the State of Delaware, this Fourth Amended and Restated Certificate of Incorporation restates and integrates and further amends the provisions of the Third Amended and Restated Certificate of Incorporation.

The text of the Restated Certificate of Incorporation as heretofore filed, amended or supplemented is hereby further amended and restated in its entirety as follows:

### ARTICLE I – NAME

The name of the corporation is Endurance Assurance Corporation.

### ARTICLE II - LOCATION

The address of the Corporation's registered office in the State of Delaware is 1209 Orange Street, City of Wilmington, County of New Castle, Delaware 19801, and the name of its registered agent at such address is The Corporation Trust Company.

### ARTICLE III – DURATION

The duration of the corporate existence of the Corporation shall be perpetual.

### ARTICLE IV – PURPOSES

The purpose of the Corporation is:

- (a) To engage in the business of multiple line insurance of any and every kind and nature and to issue any and all forms of contracts or policies with respect to property, casualty, marine, transportation and surety insurance of any kind or nature, but excluding the business of insuring policies or contracts respecting the insurance of life, life and health, or title risks;
- (b) To reinsure its risks in other companies, in whole or in part, and to reinsure risks of other companies, in whole or in part; and
- (c) To engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware.

### ARTICLE V - CAPITAL STOCK

The aggregate number of shares that the Corporation shall have the authority to issue is five million (5,000,000) shares of common stock, and the par value of each such share is one dollar (\$1.00). The amount of authorized common stock of the Corporation may be increased or decreased by the affirmative vote of the holders of a majority of the common stock of the Corporation entitled to vote.

### ARTICLE VI - CONTINUANCE

In accordance with Section 4943 of the Insurance Code of the State of Delaware, the Corporation shall be a continuance of the corporate existence of Endurance Reinsurance Corporation of America, a New York corporation, and September 5, 2002, the original date of the incorporation of Endurance Reinsurance Corporation of America, shall be the date of incorporation of the Corporation.

### ARTICLE VII - DIRECTORS

Election of directors need not be by written ballot. Any director or the entire board of directors may be removed, with or without cause, by the holders of a majority of the shares then entitled to vote, except as otherwise provided by law. In furtherance and not in limitation of the power conferred upon the Board of Directors by law, the Board of Directors shall have the power to adopt, amend and repeal the Bylaws of the Corporation.

### ARTICLE VIII - AMENDMENT

These Articles may be amended by written authorization of the holders of a majority of the voting power of the Corporation's outstanding capital stock or by affirmative vote of a majority voting at a lawful meeting of stockholders of which the notice given to stockholders included due notice of the proposal to amend.
