NARRATIVE DESECRIPTION OF ACTIVITIES

Historically this Ministry, which was previously conducted by Dobson Tape Ministry, has spread the Gospel of Jesus Christ and shared the love of Christ through its ministry to elderly people, primarily in musing homes. We have furnished Christian materials, free of charge, to musing homes and assisted living facilities, and their residents. Materials include Bibles, Bible videos, devotional books, Christian music on audiotapes and CDs, and other Christian print and electronic media. The staff of the Ministry in recent years has included only one full time person. Most of the materials furnished have been furnished by mail although some are delivered manually. The Ministry is also engaged in the following activities:

- 1. Personal visitation of institutionalized residents.
- 2. Personal visitation of shut-ins in various locations.
- 3. Personal consultation with and encouragement of nursing homes and assisted living facilities staff personnel.
- Formation and encouragement of prayer meetings among mursing home residents and staff.
- Attending conventions of nursing homes and nursing home workers to encourage Christian programs and to distribute Christian materials including those named above.
- 6. Personal appearances and written articles promoting and encouraging Christian ministry to the elderly.
- 7. Recruitment of churches to assist with Christian ministry to the elderly.
- 8. Recruitment of nursing home owners to support and provide Christian ministry to the elderly.
- Recruitment of Christian schools to encourage, promote, plan and coordinate Christian ministry to the elderly.
- 10. Recruitment of individual volunteers to promote, plan and coordinate Christian ministry to the elderly..

With regard to all of the above activities, they have been conducted by the Ministry's sole employee (Executive Director), by the Ministry's chairman and by various volunteers recruited from time to time.

The activity of furnishing Christian materials is conducted continuously. The other activities are conducted on a continual but less regular basis depending upon the circumstances.

The activities of this Ministry are conducted throughout the United States.

These activities further our exempt purposes, by providing a comprehensive Christian ministry to the elderly in nursing homes and by working to spread the Gospel of Jesus Christ.

One hundred percent of the organization's total time and efforts are applied to the above activities. The proportion applicable to each individual activity varies from time to time, but more than 50% of our total time and resources are devoted to furnishing materials as stated above.
