

Pursuant to the provisions of Section 33-31-1005 of the 1976 S.C. Code of Laws, as amended, the applicant delivers to the Secretary of State these Articles of Amendment to the Articles of Incorporation of Association of Corporate Contributions Professionals:

- 1) The name of the corporation is Association of Corporate Contributions Professionals.
- 2) The corporation was incorporated effective March 4, 2005.
- 3) On July 26, 2017, the following amendment was adopted:

Article 1. The name of the nonprofit corporation is **Association of Corporate Citizenship Professionals**.

- 4) On July 26, 2017, the Board of Directors of the corporation, for administrative and consistency of identification and marketing purposes, unanimously approved amending the Articles of Incorporation to change name of the corporation to Association of Corporate Citizenship Professionals.
- 5) Approval of the membership was not required for this administrative amendment.
