



## STATE OF DELAWARE CERTIFICATE OF AMENDMENT (A Corporation Without Capital Stock)

Starwood Associate Relief Fund, Inc., a nonstock corporation organized and existing under the laws of the State of Delaware (the "Corporation"), hereby certifies as follows:

(1) That an amendment to FIRST and THIRD clauses of the Corporation's Certificate of Incorporation was adopted on March 16, 2018 by unanimous written consent of the members of the Corporation's governing body, with said clauses, as amended, reading as follows:

"FIRST: The name of the Corporation shall be TakeCare Relief Fund, Inc. The Corporation is not organized for profit and shall not have authority to issue any capital stock."

"THIRD: The Corporation is formed and shall be operated exclusively for charitable purposes, within the meaning of Sections 170(c)(2)(B) and 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code, and, in clarification but not limitation of the foregoing, to make gifts, grants and contributions to other organizations for charitable purposes and to provide relief of all types to persons who are victims of natural disasters or acts of terrorism or who are suffering under personal hardship situations such as illness, death, accidents, and violent crimes

- (1) by operating directly for the active conduct of activities constituting such charitable purposes; and
- (2) by making distributions to other organizations or individuals for use, by the distributees, in support of such purposes.

The Corporation may engage in any and all lawful activities incidental to and in pursuit of the foregoing purposes, including the solicitation of funds, except as restricted herein."

(2) That said amendment was duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
