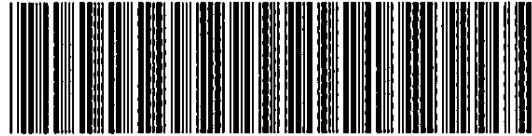


As I have advised you, I represent a small, Texas corporation that has been doing business in Florida since 1993 . It was not until the owner of the corporation came to me for legal work a few weeks ago and I spoke with the owner about the requirements of Chapter 607 that the owner realized that the corporation had to obtain a Certificate of Authority.

As I also discussed with you, my client has paid all State of Florida sales taxes, has obtained all occupational licenses and has never been advised by any governmental authority that his company had to obtain a Certificate of Authority.


Dear Ms. Tadlock :
