

In response to the letter, number 908A0037323, which we have received from you, the failure to file for qualification prior to transacting and conducting affairs in Florida was caused by our lack of related knowledge in respect to doing business in a state other than California.

Initially, we had an independent contractor working for us in the State of Florida. Due to his excellent performance, we hired him as an employee and put him on our payroll in order to maintain a closer relationship. Unfortunately, we were unaware that the act of converting an independent contractor to an employee warranted an obligation to comply with filing regulation with the State of Florida until we consulted with our CPA. In the future, we do intend to comply with the regulation of doing business in Florida.

As mentioned in our phone conversation, we have enclosed a check to pay off the amount we have owed which includes \$150 annual report/uniform business report fee and half of the penalty \$500 which you suggested, totaling \$650. 
