
Dear Ms. Hawkes:

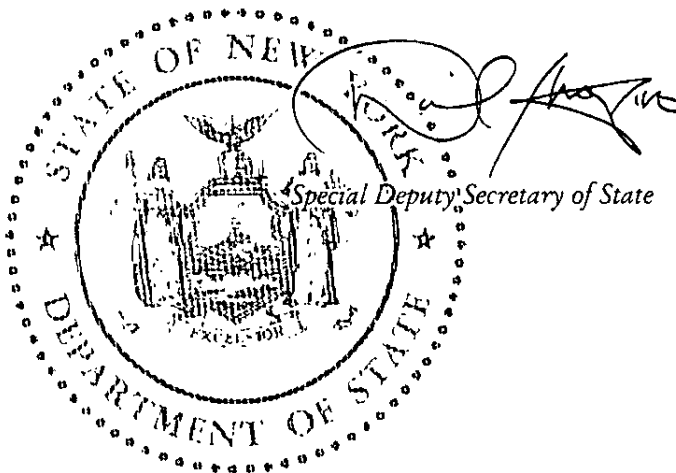

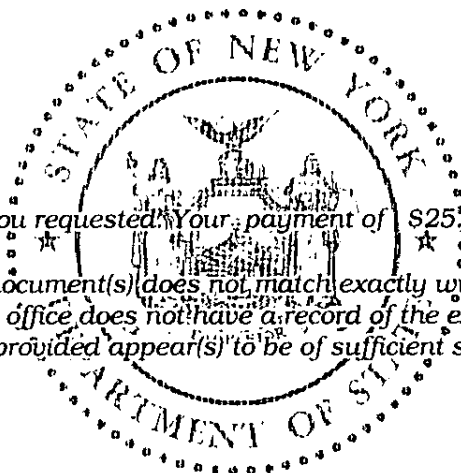
