PLAN OF MERGER

THIS PLAN OF MERGER is made this 9th day of November, 2010, by and between Jones Lang LaSalle Brokerage, Inc., a Texas corporation ("JLL Brokerage"), and the entities listed on Exhibit A anached hereto and made a part hereof, hereinafter referred to collectively as the "Merging Entities", directly and indirectly owned by JLL Brokerage.

WHEREAS, ILL Brokerage directly and through its subsidiaries owns all of the outstanding stock, units and interests of the Merging Entities.
