#### Gentlemen:

I am writing to you in the hopes that you can assist us with a problem that has been ongoing for well over a year now. This matter is having a severe negative impact on the Company and it must be resolved as quickly as possible.

In September 2007, the Company submitted an Application by a Foreign Corporation for Authorization to Conduct Business in Florida. Sometime thereafter, the State notified the Company that it was purported to be doing business in Florida prior to the date shown on the application and that a penalty was being assessed. We responded that there was an error in the dates used and that the Company did not in fact close its prior corporate headquarters in New York until the end of 2007 and that the penalty should not be assessed. The only activity that had taken place up until that date was seeking out a location and drawing up lease documents.

The application was originally submitted along with all applicable fees and schedules including the Certificate of Good Standing from New York. When I contacted the State I was informed that the \$70 fee was not paid. Although we had the canceled check for the original fee, we re-submitted the application along with another \$70 fee.

Regardless of where the State stands with this application, we need to get this matter finalized once and for all. The Company has made numerous good faith attempts to register and be in compliance with the Florida statutes and to date, has not yet received the requested approvals. Please review this matter in its entirety and regardless of cost of forms required, let us know what it will take to get this matter resolved.
