ARTICLES OF MERGER

The following Articles of Merger are submitted in accordance with Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act").

FIRST: The name and jurisdiction of the surviving entity is: DuBois Chemicals, Inc., a Delaware corporation.

SECOND: The name and jurisdiction of each merging entity is:

1. IDCH Properties, LLC, a Florida limited liability company, document number L15000158883; and
2. DuBois Chemicals, Inc., a Delaware corporation, document number F08000004157.

THIRD: The surviving entity exists before the merger, is a foreign corporation and has a certificate of authority to transact business in this state.

FOURTH: The merger was approved by IDCH Properties, LLC in accordance with Section 605.1021-1026 of the Act and by DuBois Chemicals, Inc. in accordance with the laws of Delaware, its jurisdiction of formation. The plan of merger was approved by the sole member of IDCH Properties, LLC and the board of directors of DuBois Chemicals, Inc. on the date hereof; the plan of merger did not require approval of the shareholders of DuBois Chemicals, Inc.
