
WHEREAS, the Council of Presbyters desires to make amendments to the original Articles of Incorporation;



## REVISED ARTICLES OF INCORPORATION

Adopted September 5, 2008

Revised April 29, 2011

The original Articles of Incorporation of this Corporation Sole – originally filed with the Montana Secretary of State on the 5<sup>th</sup> day of September of 2008 AD – are hereby amended in its entirety to read as follows:

### ARTICLE I – DECLARATION

I, Richard D. Wiles, the undersigned, having been duly chosen and installed as Senior Pastor and President, in conformity with the Biblical beliefs, rites, canons, rituals, bylaws, and scriptural discipline of the Church, being desirous of forming an ecclesiastical corporation for the purpose of acquiring, holding, and disposing of real, personal, and mixed property necessary or convenient for the advancement, operation, and administration of the Church's religious, charitable, educational, and benevolent ministries; and to undertake, execute, and manage the pastoral duties and responsibilities in all states and territories of the United States of America for the benefit of the ancient Christian faith founded by Jesus Christ, for public worship, and for works of charity, do hereby declare that the Flowing Streams Church decrees that the Office of the Senior Pastor and President and his successors is a non-collegial juridical person, a Corporation Sole. Furthermore, I do hereby make and subscribe the following decree:

### ARTICLE II – NAME OF CORPORATION

The name of the corporation shall be the Office of the Senior Pastor and President of the Flowing Streams Church, and His Successors, a Corporation Sole.

### ARTICLE III – SOVEREIGNTY

Flowing Streams Church is a free church that worships God freely and practices its religious faith without interference or hindrance as guaranteed by the Constitution of the United States of America.

### ARTICLE IV – DURATION

Flowing Streams Church decrees that the Office of the Senior Pastor and President of the Flowing Streams Church, and His Successors, a Corporation Sole is a body politic, a non-collegial juridical person formed as a Corporation Sole with perpetual succession according to the Constitution of the Flowing Streams Church.

### ARTICLE V – NAME OF SENIOR PASTOR AND PRESIDENT

The name of the presiding Senior Pastor and President is Richard D. Wiles

#### ARTICLE VI - TERRITORIAL JURISDICTION

Flowing Streams Church is part of the One, Holy, Universal, and Apostolic Church of Jesus Christ. Therefore, the Church and its Senior Pastor and President shall have jurisdiction in all the states and territories of the United States of America, and in all foreign countries throughout the world where individuals and/or communities of faith are affiliated with the Church and its mission.

#### ARTICLE VII - AUTHORIZATION

The establishment of this non-collegial corporation sole was authorized by a resolution unanimously adopted by the Council of Presbyters of the Flowing Streams Church.

#### ARTICLE VIII - EXECUTIVE COMMITTEE

The officers of the Church and any Trustees serving at the time shall comprise the membership of the Executive Committee. The Executive Committee members shall serve as adjunct administrators/trustees to assist the Senior Pastor/President in efficiently and wisely managing the Church's day-to-day business and ecclesiastical affairs. The Executive Committee shall advise the Senior Pastor/President in his duties as the Shepherd and Chief Executive Officer of the Church. The Executive Committee members shall execute and implement the Senior Pastor/President's policies and directives. The Executive Committee shall have no legal or legislative powers, but shall function in an advisory capacity except in matters where the Constitution and/or Bylaws has expressed powers and responsibilities and/or when the Senior Pastor/President has delegated specific powers and duties. Likewise, no member of the Executive Committee shall have any financial equity or claims of ownership in any properties, real estate, and/or assets wholly owned by the Church, its juridical person, its integrated auxiliaries, and/or incorporated apostolates. Duties and responsibilities of the Executive Committee include advising the Senior Pastor/President on ecclesiastical and business affairs; assisting the Senior Pastor/President in carrying out his spiritual and executive duties; monitoring and evaluating the Church's projects and activities; monitoring and overseeing the Church's spending and financial assets; monitoring and overseeing the Church's compliance with civil laws and regulations; assisting the Senior Pastor/President in developing a budget; assisting the Senior Pastor/President in developing a master plan for growth; monitoring and overseeing the activities of boards and committees; and assisting the Senior Pastor/President in implementing his executive decisions, policies, and directives.

#### ARTICLE IX - VACANCY

In the event of a vacancy in the Office of the Senior Pastor and President of the Flowing Streams Church, and His Successors, a Corporation Sole, the Executive Committee shall assume temporary responsibility for the oversight and management of the Corporation Sole until an interim or permanent successor is chosen and installed according to the Constitution and/or Bylaws of the Flowing Streams Church. The Executive Committee

shall appoint a temporary Executive Administrator to whom it shall delegate the executive and administrative functions of the Corporation Sole during the vacancy and until such time that a successor is duly chosen and installed according to the Constitution and/or Bylaws of the Flowing Streams Church. The Executive Committee shall present a written resolution to the Montana Secretary of State certifying the appointment of the temporary Executive Administrator. The resolution shall be signed by the temporary Executive Administrator and two or more members of the Executive Committee, and contain the seal of the Church. During the vacancy, the temporary Executive Administrator shall be subordinate to the instructions of the Executive Committee. The temporary Executive Administrator shall not disobey the instructions and policies adopted by the Executive Committee during the transition period until an interim or permanent replacement for the Senior Pastor/President is duly chosen and installed in the Office of the Senior Pastor and President of the Flowing Streams Church, and His Successors, a Corporation Sole. During the vacancy, neither the Executive Committee nor temporary Executive Administrator shall be empowered to sell, transfer, or encumber with debt, liens, and/or mortgages any Church property and/or assets; nor shall they be empowered to close existing financial accounts or open new financial, banking, or investment accounts in the name of the Corporation Sole. This prohibition does not forbid the normal and reasonable transfer of funds to accounts necessary to conduct the Church's business.

#### ARTICLE X - SUCCESSION

Upon the termination of employment, reassignment to another church or position; or the death, resignation, retirement, permanent incapacitation; or dismissal of the Senior Pastor/President by the appropriate ecclesiastical official(s) in the Church, a successor shall be chosen and installed, according to the Constitution of the Flowing Streams Church, in the Office of the Senior Pastor and President and His Successors, a Corporation Sole. The Executive Committee shall execute a resolution certifying the appointment of the successor. The resolution shall be signed by the successor and at least two members of the Executive Committee, and shall contain the Church seal. The document shall be sent to the office of the Secretary of State of Montana. The duly chosen and installed successor shall be vested with the title of all property held by the successor's predecessor - real, personal, and mixed - with the same power and authority over the property, subject to all the legal liabilities and obligations with reference to the property.

#### ARTICLE XI - AMENDMENTS

The Senior Pastor and President may at any time amend the Articles of Incorporation of this Corporation Sole according to the procedures and guidelines set forth in the Constitution and/or Bylaws of the Flowing Streams Church. The Senior Pastor and President shall sign and verify a written statement setting forth the provisions of the amendment(s) and stating that he is duly authorized by the Church's Constitution to make the amendment. The amendment(s) shall be submitted to the Montana Secretary of State.

These revised Articles of Incorporation, adopted on April 29, 2011, are effective immediately and shall supersede the original Articles of Incorporation adopted on September 5, 2008.

ARTICLE XIII - INCORPORATOR

The incorporator is Richard D. Wiles, acting as Senior Pastor and President of the Flowing Streams Church.


