- 5. Principal Office. The complete address of the principal office of the corporation in the State of Tennessee is 3811 Crystal Springs Lane, Hermitage, Tennessee 37076, in Davidson County.
- 6. Nonprofit. The corporation is nonprofit.
- 7. Purposes. The purposes for which this corporation is organized are to:

To be an agency of God for evangelizing the world;

To be an agency of God to encourage and promote the worship of God and the exaltation of His son, the Lord Jesus Christ;

To encourage and promote the edification of Christian believers, and to be a channel of God's purpose to build, edify, teach, encourage, and strengthen the fellowship of those of like precious faith in the Lord Jesus Christ;

To establish and maintain such ministries, outreaches, departments and institutions as may be necessary for the propagation of the Gospel of Jesus Christ and the evangelization of the world; and

To do everything and anything reasonably and lawfully necessary, proper, suitable, or convenient for the achievement of the purposes above stated, or for any of them, or for the furtherance of the said purposes.

This corporation shall not engage in any activities that are unlawful under applicable federal, state or local laws, including but not limited to, Section 501(c) of the Internal Revenue Code, excepting any such law which infringes upon any rights of the corporation protected by the Constitution of the United States, such as freedom of religion and freedom of speech.

To solicit, collect, receive, accumulate, administer and disburse funds and property in such a manner as will, in the sole discretion of the board of directors, most effectively operate to promote the corporation's tax-exempt purposes, either directly or by contributions to
