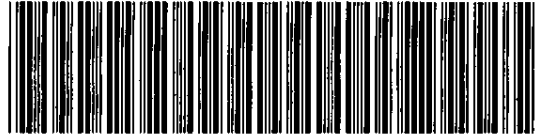

To Whom It May Concern,

We've recently learned that our company, Academy Mortgage Corporation, is not actively registered with the Florida Division of Corporations. We originally registered with the division on 02/02/2005 under our name and also the fictitious name "Academy Home Lending". Academy Mortgage Corporation withdrew from the division in September of 2007, not knowing that we would need to be doing business in Florida again in 2008. However, when I came into the licensing position in July of 2008, it appeared to me that we were ok because our fictitious name "Academy Home Lending" still showed active on your website. We did not realize that this was not true since the owner of the name, "Academy Mortgage Corporation", had withdrawn in 2007. We tried to correct this situation by immediately applying for authority to do business in Florida under a name that was available, Nationwide Academy Mortgage Corp., and received the attached reply with a fine attached.

We understand that we must pay fees that cover the time we were not registered, but this should only be for 2008 since we just withdrew in 09/2007. We mistakenly put 02/02/2005 on the form, as we interpreted that to mean when we originally began business in FL.

Please let me know what we can do to rectify this situation immediately, and what fee we actually owe.

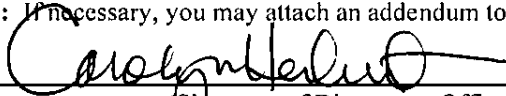

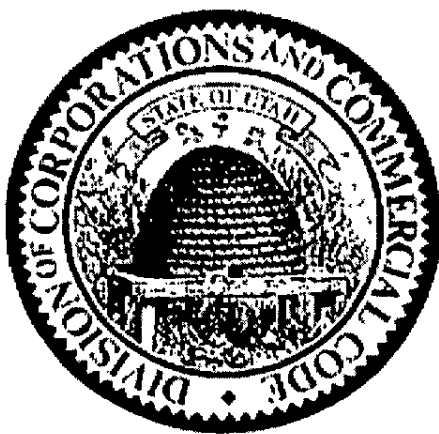
