

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
ROBINSON-ADAMS INSURANCE, INC.

IN THE OFFICES OF THE JUDGE OF PROBATE
OF JEFFERSON COUNTY, ALABAMA

Pursuant to the provisions of § 10A-2-10.06 of the Code of Alabama, (1975), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ROBINSON-ADAMS INSURANCE, INC., (the "Corporation").
2. The following amendment was adopted in the manner prescribed in the Alabama Business and Nonprofit Entity Code in order to facilitate the name change from ROBINSON-ADAMS INSURANCE, INC., to WOODCREST SERVICES, INC.

ARTICLE ONE of the Articles of Incorporation is hereby deleted and the following new ARTICLE ONE is substituted in lieu thereof:

ARTICLE 1: The name of the corporation shall be and is: WOODCREST SERVICES, INC., and the corporation shall be authorized to trade in said name or to use any other trade name not now being used by any other person, firm or corporation.

3. The amendment was adopted by the shareholders or directors in the manner prescribed by law on August 19, 2011.

4. The number of shares outstanding at the time of the adoption was Ten Thousand (10,000), the number of shares entitled to vote thereon was Ten Thousand (10,000). All outstanding shares were common stock, the holders of which were entitled to one vote per share.

5. The number of shares voted for the amendment was Ten Thousand (10,000); and the number of shares voted against such amendment was Zero (0).
