CERTIFICATE OF AMENDMENT OF THE CHARTER

OF

MUNICIPAL AND INFRASTRUCTURE ASSURANCE CORPORATION

Pursuant to the provisions of Section 1206 of the New York Insurance Law and Section 805 of the New York Business Corporation Law, the undersigned President and Secretary of Municipal and Infrastructure Assurance Corporation (the "Corporation"), hereby certify as follows:

FIRST: The name of the Municipal and Infrastructure Assurance Corporation.

SECOND:

The Charter of the Corporation was originally filed with the New York State Department of Financial Services (successor to the New York State Insurance Department) on August 21, 2008 (the "Charter").

THIRD:

The amendments to the Charter effected by this Certificate of Amendment are (i) to Article I to change the name of the Corporation to "Municipal Assurance Corp." and (ii) to Article V (a) to revise the director requirements to provide that the directors of the Corporation shall be not less than seven, nor more than twenty-one, and (b) to decrease the number of directors of the Corporation that are required to be residents of the State of New York from two to one.

FOURTH:

Article I of the Charter is hereby amended and restated in its entirety to read as follows:

"ARTICLE I

NAME THE

The name of the corporations Municipal Assurance Corp. (the "Corporation")."

FIFTER 0 1 2000 Cle V of the Charter is hereby affinended and restated in its entirety to

"ARTICLE V

NUMBER OF DIRECTORS; QUALIFICATIONS

The number of directors of the Corporation shall be not less than seven (7), nor more than twenty-one (21), and shall be determined by or under the By-Laws. As used in this paragraph, "number of directors" means the total number of directors that the Corporation would have if there were no vacancies. Directors shall be elected at each annual meeting of shareholders and each director so elected shall hold office until the next annual meeting of shareholders and until his or her successor is elected and qualified or until his or her earlier death, resignation or removal. In the event that the number of directors duly elected and serving shall be less than seven (7), the Corporation shall not for that reason be dissolved, but the vacancy or vacancies shall be filled as provided in Article VII hereof. Each director shall be at least twenty-one years of age. At all times a majority of the directors shall be citizens and residents of the United States and not less than one (1) of the directors shall be a resident of New York. The directors need not be shareholders of the Corporation."

SIXTH:

The foregoing amendments to the Charter of the Corporation were authorized by the resolution of the Board of Directors of the Corporation on the 5th day of September 2012, followed by action of the sole shareholder of the Corporation on the 3rd day of January 2013.
