AMENDMENT to the ARTICLES OF INCORPORATION of The Louisville Fund for Adult Children, Inc.

Pursuant to KRS 14A and KRS 273

The following amendments to the Articles of Incorporation were adopted by the Board of Directors of The Louisville Fund for Adult Children, Inc. on May 18, 2014:

Article I: Name

The name of the corporation shall be The Food Addiction Institute, Inc.

Article II: Purpose

The purpose for which the corporation is organized:

To provide awareness, education and training about chemical dependency on food and support for long-term recovery from food addiction, with the following specific objectives:

- 1) Define and expand the body of scientific and medical knowledge about food addiction.
- 2) Provide professional training and public education about food addiction as a treatable chemical dependency.
- 3) Offer information about promising practices for treatment and supply resources for those who may be food addicted.
- 4) Create a forum for innovative and effective public health strategies for food addiction in the United States and in the world.
