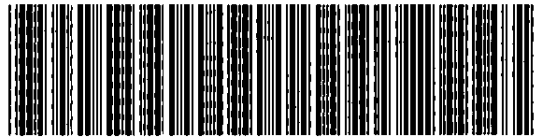

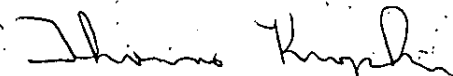
Also enclosed is the certification fee of \$87.50 for the filing fee, Certificate of Status, and a Certified Copy.

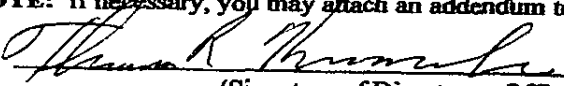

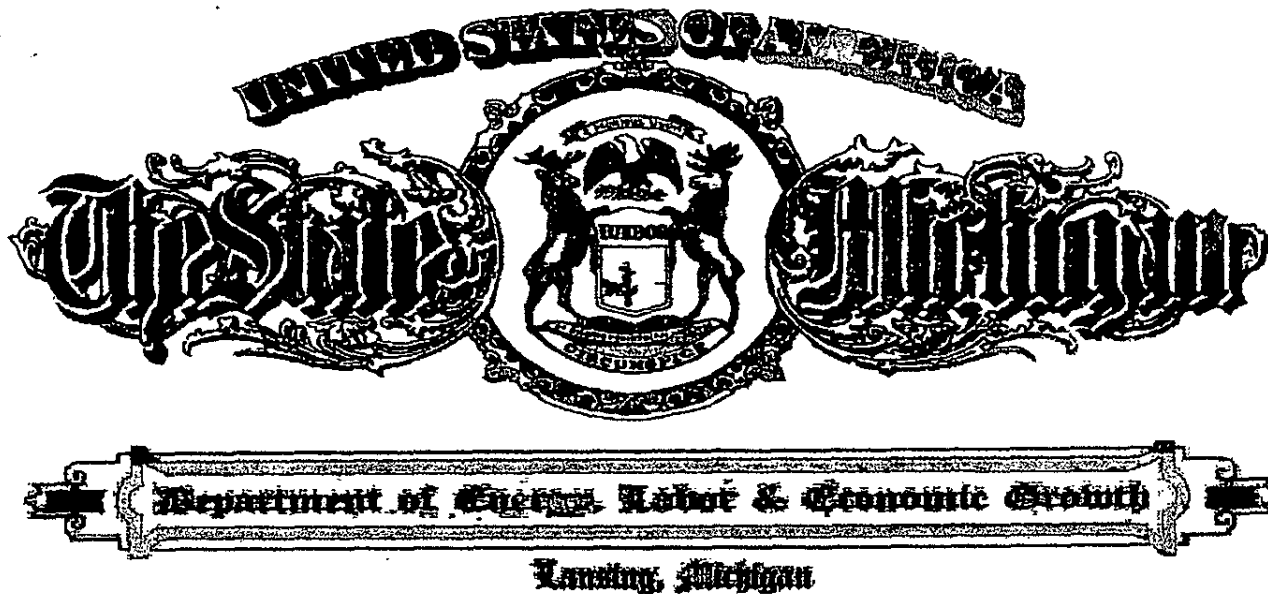
