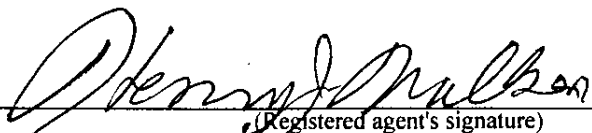

CERTIFICATE OF AMENDMENT  
OF THE  
CERTIFICATE OF INCORPORATION  
OF

NEW LIFE CHURCH OF THE APOSTLES DOCTRINE, INC.

FIRST: The name of the corporation is: New Life Church of the Apostles Doctrine, Inc.

SECOND: The date of filing of the certificate of incorporation with Suffolk County was Dec 30, 1982, under index number 1.

THIRD: The purpose or purposes for which the corporation was formed are as follows:  
To hold services of divine worship, prayer meetings, evangelistic meetings, bible study, and teaching of the Gospel.

To publish, record and promote all materials necessary to promote the Gospel.  
To establish and maintain Ministry schools to teach and study the Gospel of Jesus Christ and the Holy Scriptures, provided however that said Ministry shall not teach or promote the teaching of any other subject other than religious education.

The corporation, in furtherance of its corporate purposes above set forth, shall have all the powers enumerated in Section 181 of the Religious Corporations Law, subject to any limitations provided in the Religious Corporations Law, or any other statute of the State of New York.

To do any other act or thing incidental to or connected with the foregoing purposes or in the advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, or officers except as permitted under Article 2 of the Religious Corporations Law.

In furtherance of its purposes, the corporation shall have all general powers enumerated in the religious Corporations Law, together with the powers to solicit grants and contributions for corporate purposes.

No part of the income of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual, except the reasonable compensation which may be paid for services rendered to or for the corporation affecting one or more of its purposes and no member, trustee, officer of the corporation or private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the corporation.

No part of the activities of the corporation shall be carrying on propaganda or otherwise attempting to influence legislation or participate in or intervening in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office.

In the event of dissolution, all the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to such organizations



as shall qualify under section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, subject to an order of a Justice of the Supreme Court of the State of New York.

To purchase, receive, lease or otherwise acquire and to manage, hold, own, use, improve, convey, sell, mortgage or otherwise deal in and with lands, buildings and real property of every description or any interest therein.

FOURTH: The amendment effected by this certificate of amendment is as follows:

Paragraph FIRST of the Certificate of Incorporation relating to New Life Church of the Apostles Doctrine, Inc. is hereby amended to read in its entirety as follows: NEW LIFE REVIVAL INTERNATIONAL, INC.

FIFTH: The certificate of amendment was authorized by a vote of the entire board of directors on September 6, 2004.
