- 9. To open a bank account with any bank at USA in the name of "ADVENTUROUS ASSOCIATION OF GUJARAT INC.". The bank account will be operated by signature of any one out of Yogini Modi - "President- AAGInc" or Rajendra Modi - "Vice President- AAGInc" If personal presence of officers is necessary to open the proposed bank account, Bryan Shelton -- "Registered Agent AAGInc" is empowered to open and operate the bank account as per the instructions of President/Vice President of AAGInc, till the President/Vice President visit and execute necessary changes with the bank account.
