In response to our phone conversation of May 12, I am attaching copies of our first efforts to register in Florida last fall. After review of the information on the website, Sunbiz.org and calling to clarify the process, we filed for a fictitious name registration.

It was our understanding that, as we do not actually do business in the State that this was the appropriate approach. We do have several Sertoma clubs in Florida, but each of those are a separate corporation, our need was only to open a bank account for a volunteer to manage reimbursement of expenses locally.

After we received the first rejection, it was our understanding that we had an issue with the name we wanted to register. It had been used previously, before we changed our corporate structure -- a change that directly affected our functional relationship with the volunteers. It was not until that application was returned, and with the assistance of Leigh at Sunbiz.org (I apologize, I did not capture her last name from the call on 3/16/09) that we became aware of the appropriate process.

We are a small national charity, and have with due diligence been working to appropriately register so we can open this one bank account in Florida. As such, I would request that any penalties and related interest be dismissed.
