Thank you for your letter dated 7/1/09 regarding Merit Resources, Inc. I called your office on 7/15/09 to speak with you regarding the letter but you were not available. I was told to put our response to your letter in writing.

We inadvertently typed 1/1/91 as the first date we transacted business in Florida on the application but actual first pay date in Florida was 6/16/93.

Merit Resources only had approximately one employee in Florida from 1993 to 1997 that was a satellite employee for one of our clients. We were advised that we did not need to file for authorization to transact business as a foreign corporation because of the de minimis level of activity.

From 1998 to 2000, we had only approximately five employees and we were still under the understanding that we did not need to file for authority because of the small size of transactions.

In 2001, Merit Resources Inc purchased a corporation, LKI Group Inc Which is domiciled in Florida and had authority to transact business in the state of Florida as it is domiciled there. LKI Group Inc became a wholly owned subsidiary of Merit Resources Inc at the time of purchase. We were told that Merit could have employees in the state because of the parent-child relationship between Merit Resources Inc and LKI Group Inc. In addition, a dba was filed and approved for LKI Group, Inc. to transact business as Merit Resources.

The combined entities of Merit Resources would like to do more expansion in your state. That is why we have applied for the authority to transact business as we intend to increase the revenue and accompanying taxes to be generated in Florida.
