RESTATED ARTICLES OF INCORPORATION

OF

SUPERIOR PLUS CONSTRUCTION PRODUCTS CORP.

ARTICLE I.

NAME AND TERM

The name of the Corporation shall be FBM GALAXY, INC. The term of the Corporation's existence shall be perpetual.

ARTICLE II.

STATUTORY AUTHORITY

The Corporation is incorporated under the Pennsylvania Business Corporation Law of 1988, as amended ("PBCL").

ARTICLE III. REGISTERED OFFICE
