



## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF DILLING MECHANICAL CONTRACTORS, INC.

The undersigned officer of Dilling Mechanical Contractors, Inc. (hereinafter referred to as the "Corporation"), existing pursuant to the provisions of the Indiana Business Corporation Law as amended (hereinafter referred to as the "Act"), desiring to give notice of corporate action amending its Articles of Incorporation of the Corporation, certifies the following facts:

- Section 1. **Information**. The name of the Corporation is Dilling Mechanical Contractors, Inc. After the effectiveness of this amendment, the name of the Corporation will be Dilling Group, Inc. The date of incorporation of the Corporation is December 14, 1984.
- Section 2. Amendments. The exact text of Article I of the Corporation's Articles of Incorporation is now as follows:

#### "ARTICLE I Name

The name of the Corporation is Dilling Group, Inc."

#### Section 3. Manner of Adoption and Vote.
