

ADDENDUM

8. Purpose(s) of corporation authorized in home state or country to be carried out in the state of Florida:

A. This corporation is organized exclusively for one or more purposes as specified in Section 501(c)(3) of the IRC, including for such purposes, the making of distribution to organizations that qualify as exempt organizations under IRC Section 501(c)(3). No substantial part of the activities of this corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation [except as otherwise provided by IRC Section 501(h)]. Notwithstanding any other provisions, this corporation shall not carry on any activities not permitted (a) by an organization exempt from federal tax under IRC Section 501(c)(3), or (b) by an organization, contributions to which are deductible under IRC Section 170(c)(2).

B. This corporation operates in a manner that is in compliance with regulations regarding non-profit organizations registered under Section 501(c)(3), Internal Revenue Code of 1954 as amended, which include these rules:

1. Our net earnings may not inure to any private shareholder or individual.
2. We must not provide a substantial benefit to private interests.
3. We must not devote a substantial part of our activities to attempting to influence legislation.
4. We must not participate in, or intervene in, any political campaign on behalf of (or in opposition to) any candidate for public office.
5. No part of our purposes or activities may be illegal or violate fundamental public policy.

The specific purposes of this corporation are:

1. To proclaim the good news of salvation by faith in our Lord Jesus Christ and His full Gospel by any suitable method or media, which includes but is not limited to the following:

a. Establishing and operating a Christian faith-based teaching and outreach ministry for the salvation of lost souls, using personal evangelism, television, radio, crusades, conventions, preaching, outdoor activities, missions and other Christian methods.

b. Assisting and furthering the task of providing Biblical teaching and principles to all who will hear through printed material, speakers, electronic media and any other method that is now or may become available; and

c. Providing a "network" for reaching out and ministering the love of God, faith in His Word, and the power of His Spirit as well as supporting and cooperating with other

ministries having the same spirit of faith in order to build a strong foundation of faith into the people of God.

SPIRIT OF FAITH OUTREACH MINISTRIES' vision is to empower people of all ages to experience salvation and walk in the power, prosperity, authority, dominion, and destiny God made available through the LORD Jesus Christ.

The Ministry's primary goal is to teach the full Gospel – the uncompromised Word of God – and minister to men, women, and children through:

- (1) the message of the LORD Jesus Christ,
- (2) the power of the Holy Spirit, and
- (3) Christ's example of *faith, agape love, integrity, truth, and hope*.

The Ministry's key objectives are:

- (1) to teach and demonstrate *Faith* in God and the power of His might,
- (2) to teach and demonstrate *Agape love* to all people at all times,
- (3) to teach and demonstrate *Integrity* at all times and in all things,
- (4) to teach and demonstrate *Truth* of the Word of God, and
- (5) to teach and demonstrate *Hope* in the Lord Jesus Christ and the power of the Holy Spirit.

The Ministry's vision, mission, goals, and objectives are accomplished through the God-inspired operation and support of various ministry activities. The purpose of this Ministry shall be to preach, teach, live, disciple, and support others – including other ministries – in the ministry focus areas (core values) of Faith, Agape, Integrity, Truth, and Hope.

2. To be obedient to God in all that He directs be done in the furtherance of the Gospel to bring glory to His son, Jesus Christ.

The general purposes and powers of the corporation are:

1. To have and to exercise all rights and powers conferred upon nonstock corporations under the laws of the Commonwealth of Virginia, including the power to contract, rent, buy or sell personal or real property provided however that this corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers not in the furtherance of the primary purposes of this corporation.

2. To do all things necessary, expedient or appropriate to the accomplishment of any of the objects and purposes for which this corporation is formed.

Notwithstanding any of the above, no substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign, including the publishing or distribution of statements, on behalf of any candidate for public office.
