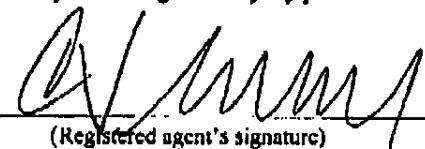

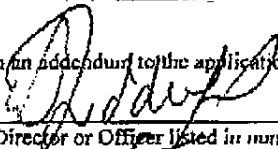

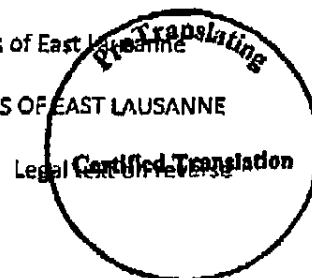

Right to consult

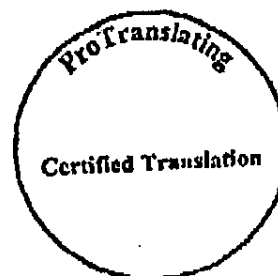
1 Any person may consult the reports and the records of the legal proceedings and bankruptcy offices and have extracts thereof issued thereto, provided that he demonstrates that he has a valid interest therein.

2 This interest is rendered valid particularly when the request for an extract is directly linked to the execution or settlement of a contract.

3 The offices may not make known to third parties:

- a. void proceedings as well as those which were rendered null and void as a result of a complaint or a judgment;
- b. proceedings for which the debtor has won the action for the recovery of a payment made by mistake;
- c. proceedings withdrawn by the creditor.

4. The right to consult of third parties expires five years after the close of the proceedings. The judicial and administrative authorities may still, in the interest of proceedings pending before them, request the issuance of an extract.
