# CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION OF MG MALLS HOLDINGS, INC.

Pursuant to Section 242 of the General Corporation Law of the State of Delaware

FIRST: The name of the Corporation is MG MALLS HOLDINGS, INC. (the "Corporation").
