## **Addendum 1**

### **Question 8**

This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code as now enacted or hereafter amended.

To this end, the corporation shall:

Provide short term financial assistance to members of the Greenwich Town Community residing in the U.S. who have lost the financial support of a primary breadwinner due to a sudden grave illness or tragic death. Our goal is to be a bridge to long-term solution by offering immediate, interim financial assistance that will help to sustain the family's standard of living and help them avoid becoming destitute and a public charge.

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes. The corporation, in furtherance of its corporate purposes above set forth, shall have all the powers enumerated in section 202 of the Not-for-Profit Corporation Law, subject to any limitations provided in the Not-for-Profit Corporation Law or any other statute of the State of New York. Nothing herein shall authorize this corporation, directly or indirectly, to engage in, or include among its purposes, any of the activities mentioned in the Not-for-Profit Corporation Law, Section 404(b)-(u).

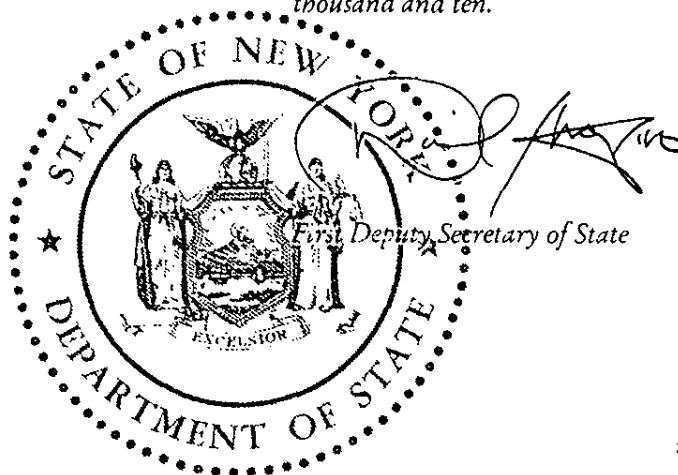
