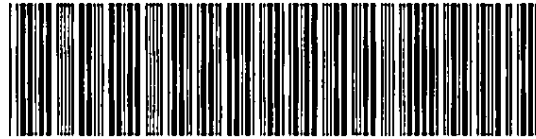

Name Change Amendment

Mr. Grimm,

The Florida Department of State, Division of Corporations, received the Application by Foreign Profit Corporation to File Amendment to Application For Authorization to Transact Business in Florida for the above referenced corporation on November 29, 2021. The Illinois company changed it's name from THOMAS A. KLYM & ASSOCIATES, LTD. (authorized in Florida as THOMAS A. KLYM & ASSOCIATES, LTD. CORP.) to THOMAS A. KLYM, CPA, P.C.

Chapter 621, Florida State, provides for a Florida entity to incorporate as a professional association, it does not have a provision for a foreign corporation to qualify for authorization to transact business in Florida as a professional association. The foreign entity would need to comply 607.0401 (1)(a), F.S., by adding the corporate indicator. This was required when THOMAS A. KLYM & ASSOCIATES, LTD originally qualified in 2010 by adding "CORP." to the name.


Once the name change has been filed a fictitious name can be registered for THOMAS A. KLYM, CPA, P.C., 865.09 (14) (e), F.S., under Prohibitions may not contain the following words: *"Professional association," "PA," "P.A.," or "chartered," unless the person or business for which the name is registered is organized as a professional corporation pursuant to chapter 621, or is organized as a professional corporation pursuant to a similar law of another jurisdiction and has obtained a certificate of authority to transact business in this state pursuant to chapter 607.allows"*

The fictitious name can be registered online, or by paper using the application prescribed by the Division of Corporations. There is a \$50.00 registration fee.

With your permission, I can add "corporation," "company," or "incorporated" or the abbreviation "Corp.," or "Inc.," or "Co.," or the designation "Corp.," or "Inc.," or "Co" to the name and file the amendment.
