Thank you for speaking with me on Tuesday, September 21, 2010 about Africa Car Carrier - ACC (Off Shore), a company incorporated in Lebanon ("ACC"). Attached is an Application by Foreign Corporation for Authorization to Transact Business in Florida for ACC.

As we discussed, in Section 1 of this Application, ACC has been named "ACC Africa Car Carrier - ACC (Off Shore) (a Lebanese corporation)" for the purpose of doing business in Florida. We have altered ACC's name because ACC is filing a Form FMC-18 Application for a License as an Ocean Transportation Intermediary (the "OTI Application") with the Federal Maritime Commission (the "FMC"). The FMC has notified us that it will reject ACC's OTI Application if ACC places the words "Incorporated" "Company" or "Corporation" immediately after its name. The FMC has agreed, though, to accept the words "a Lebanese corporation" in parentheses after ACC's name.

Additionally, we have attached copies of the original and translated versions of ACC's Lebanese Certificate of Existence for your review.

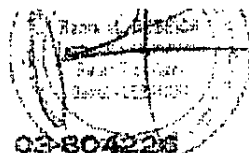

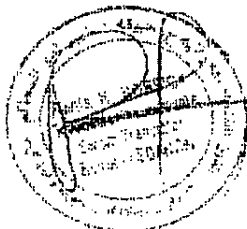
