Christian Credit Counselors, Inc. ("CCC") is applying for Authority to Transact Business in the State of Florida. To that end, the following documents are enclosed:

3. A Certificate of Existence from Michigan where CCC is incorporated; and

I would like to take this time to offer an explanation about item 6 on the Application form. As you will note, it indicates that we have been doing business since February 2009 without registering with the Division of Corporations. This was through error however. In 2009, CCC filed a Name registration with the Division of Corporations and was given document number E0900000009. The letter said that the name would have to be renewed each year before December 31. The staff at the time thought this was the same as applying for authority, and it was only through inquiring about the renewal in December 2010 that it was discovered that this was not the correct registration. As you can see, CCC is attempting to rectify this error as soon as it was learned.



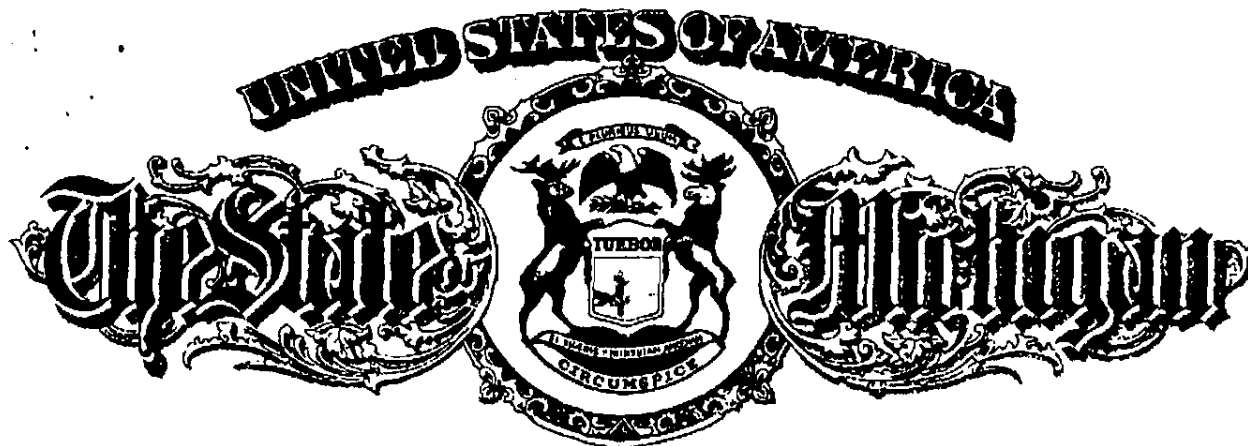
