

 - 2) Notwithstanding any other provisions of these articles, the purposes for which the corporation is organized are exclusively religious, scientific, literary and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 (the "Code") or the corresponding provision of any future United States Internal Revenue law.
 - 3) Notwithstanding any other provisions of these articles, this Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Code corresponding provision of any future United States Internal Revenue law.
