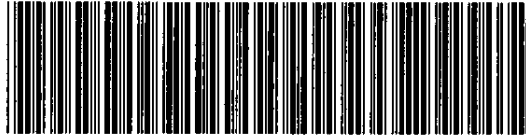

3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.

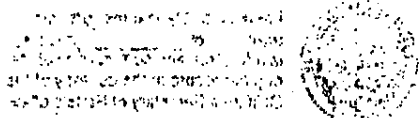
