

This letter amplifies our short telephone conversation of June 10, 2011, in which you informed me that the intent to pose a civil penalty is based upon our response on Line 6 of the application on behalf of Mednet Global Corporation.

The entry on Line 6 may have been misleading without further explanation. Please be advised that Mednet Global Corporation was originally authorized to do business in the State of Florida in 2008, and filed an annual report on January 11, 2010 for the year 2009. That information is reflected on the detail of the Division of Corporation's computer records. The original application was submitted to the State on January 3, 2008. Please be advised that Mednet Global Corporation was authorized to enact business in the State of Florida and was so qualified on February 1, 2008, and did submit an application for withdrawal of such authority on January 10, 2011, since it anticipated doing no further business in the State of Florida. However, since that time there has been a change in the business outlook for Mednet Global Corporation, and again it is anticipated that they will be conducting business in the State of Florida as soon as properly authorized by the Secretary of State. Therefore, since Mednet Global Corporation was authorized to do business in the State of Florida in 2008 and subsequently, no penalty or additional annual report filing fee should be applicable, as Mednet Global Corporation properly filed its Florida Annual Report when due. Please commence reprocessing Mednet Global Corporation's application. Please call if you have questions.


