This letter is in response to your correspondence with my client Yvon Renault dated June 2, 2011. Mr. Renault submitted an Application by Foreign Corporation for Authorization to Transact Business in Florida for his foreign corporation 506172 N. B. Inc. He took it upon himself to fill this application in its entirety without the advice of myself. Unfortunately, in doing so, he filled some of the information incorrectly.

On the application, Mr. Renault indicated that he began doing business in Florida in 2010. In turn, your office returned his application to him with the enclosed letter assigning him a \$500 civil penalty for conducting business prior to properly registering with the Florida Department of State, Division of Corporation. However, 506172 N. B. Inc did not conduct business in the State of Florida until 2011. The foreign corporation purchased a property to be a residential rental in June of 2010. The property did not begin generating rental income until 2011.

According to Florida Statute 607.1501 Subsection (2), owning real or personal property does not constitute transacting business within the meaning of Subsection (1). Therefore, 506172 N. B. Inc did not conduct business in the State of Florida until 2011. My client will submit an amended application with the correct date of beginning business.

Please accept this as a written request to abate the \$500 civil penalty on the grounds that 506172 N. B. Inc was not in fact conducting business in the State of Florida in 2010.


