To effect such amendment:

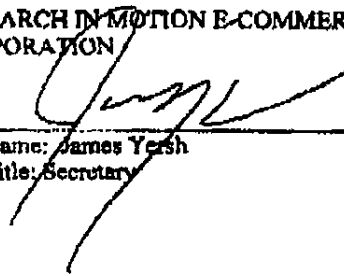
Paragraph "1." of the Certificate of Incorporation is hereby amended to read in its entirety as follows:
