(15 Pa.C.S.) Business Corporation (§1915)

In compliance with the requirements of the applicable provisions (relating to articles of amendment), the undereigned, desiring to amend and restate its articles of incorporation, hereby states that:

ARTICLE 1

The name of the Corporation is REAL TIME SURVEILLANCE AND SECURITY, INC.

ARTICLE 2
