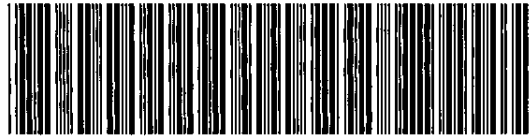

I am the sole principal of UDC USA, INC., f/k/a Ukrainian Defense Consulting Ltd., an Illinois corporation (the "Corporation") authorized to transact business in Florida under the name "Ukrainian Defense Consulting Ltd., Inc." On March 28, 2012, the Corporation changed its corporate name in Illinois from "Ukrainian Defense Consulting Ltd." to "UDC USA, INC." A copy of the Illinois Articles of Amendment documenting this change is enclosed herewith.

Shortly thereafter, the Corporation submitted an application with the Florida Department of State to change its name in Florida to "UDC USA, INC." in order to reflect its name change in Illinois. However, on April 17, 2012, the Corporation received a letter from the Florida Department of State informing it that the name "UDC USA, INC." was not available in Florida. A copy of that April 17<sup>th</sup> correspondence is enclosed herewith.

Upon receipt of such letter, Meghan Fonte, the Contracts/Subcontracts Administrator for the Corporation, contacted you in order to determine why the name was not available. Based upon those conversations, it was determined that the name "UDC USA, INC." was not available as there was already a Florida limited liability company with the name "UDC USA, LLC."

However, I am also the sole member and sole managing member of UDC USA, LLC. On May 7, 2012, Articles of Dissolution were filed with the Florida Department of State to dissolve UDC USA, LLC, a copy of which is enclosed herewith.

Pursuant to your discussion with Ms. Fonte, the purpose of this letter is to inform the Florida Department of State that I hereby release the name "UDC USA, LLC" so that the Corporation may immediately use the name "UDC USA, INC." in Florida. As managing member of UDC USA, LLC, I further agree to not revoke the dissolution nor reinstate UDC USA, LLC.


