CERTIFICATE OF INCORPORATION

OF

YESHIVAT OHR YERUSHALAYIM, INC.

Under Section 402 of the Not-For-Profit Corporation Law

IT IS HEREBY CERTIFIED THAT:

- 1. The name of the corporation is YESHIVAT OHR YERUSHALAYIM, INC.
- YESHIVAT OHR YERUSHALAYIM, INC. is Hebrew for Yeshiva (School) of the Light of Jerusalem.
- The corporation is a corporation as defined in subparagraph (a)(5) of Section 102
 (Definitions) of the Not-For-Profit Corporation Law.
 - 3. The purpose or purposes for which the corporation is formed are as follows:

To assist in promoting Yeshivat Ohr Yerushalayim to potential students in the United States. (Yeshivat Ohr Yerushalayim is a post-high school religious and educational institution for American teenage boys, located in Beit Meir, Israel);

To assist in recruiting potential students located in the United States in attending Yeshivat Ohr Yerushalayim;

To solicit and provide funds in the United States to help provide educational and need based scholarships for students from the United States attending Yeshivat Ohr Yerushalayim;

To serve as a liaison between parents of students from the United States who are attending Yeshivat Ohr Yerushalayim; and

To, assist in the collection of tuition payments from students in the United States who are attending Yeshivat Obr Yerushalayim.

- 4. In furtherance of its corporate purposes, the corporation shall have all the general powers enumerated in Section 202 of the Not-For-Profit Corporation Law, together with the power to solicit grants and contributions for the corporate purposes.
 - 5. Nothing herein shall authorize this corporation, directly or indirectly, to engage in

- 8. Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes as specified in §501(c)(3) of the Internal Revenue Code, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC § 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.
- 9. No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.
 - 10. No substantial part of the activities of the corporation shall be carrying on

propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code section 501(h), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.

- 11. In the event of dissolution, all of the remaining assets and property of the corporation shall after necessary expenses thereof be distributed to another organization exempt under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for a public purposes, subject to an order of a Justice of the Supreme Court of the State of New York.
- 12. In any taxable year in which the corporation is a private foundation as described in section 509(a) of the Internal Revenue Code, the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under section 4942 of the Code; and the corporation shall not (a) engage in any act of self-dealing as defined in section 4941(d) of the Code; retain any excess business holdings as defined in section 4943(c) of the Code; (c) make any investments in such manner as to subject the corporation to tax under section 4944 of the Code; or (d) make any taxable expenditures as defined in section 4945(d) of the Code or corresponding provisions of any subsequent Federal tax laws.
- 13. No corporation having the power to solicit contributions for charitable purposes may solicit contributions for any purpose for which approval of such solicitation is required under the provisions of \$404 of this chapter unless the certificate specifically makes provision for such solicitation and the required written approval is endorsed on or annexed to such certificate or unless the corporation is among those referred to in \$172-a of the executive law. If such approval is not obtained and the corporation continues to solicit or receive contributions for such purpose or

advertises that it has obtained such approval, the attorney general, at the request of the officer or body authorized to grant such approval, shall maintain an action or proceeding pursuant to the provisions of subparagraph one of paragraph (a) of \$112 of this chapter. Such an action may also be maintained in relation to a corporation hereinafter incorporated if the name, purposes, objects of the activities of such corporation may, in any manner, lead to the belief that the corporation possesses or may exercise any of such purposes.

- 14. The office of the corporation is to be located in the City of New York, County of Queens, State of New York.


