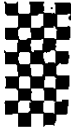

**ARTICLES OF AMENDMENT**

**OF**

Pursuant to §55-10-06 of the North Carolina General Statutes, the undersigned Corporation hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation.

1. The name of the Corporation is Cunningham & Company (the "Corporation").
2. The Articles of Incorporation of the Corporation shall be amended by deleting the entire text of Article I thereof and substituting in its place the following:

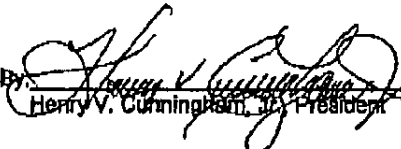
**"ARTICLE I.**
