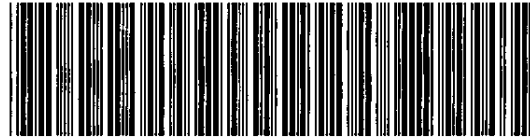

**CERTIFICATE OF INCORPORATION**

**OF**

Under Article 10 of the Religious Corporation Law

We, the undersigned, all being persons of full age, all of us residing in the State of New York and desiring to form a Religious Corporation pursuant to Article 10 of the Religious Corporation Law, hereby certify as follows:

**FIRST:** A meeting of **Netzach Israel Zichron Aaron Inc.** an unincorporated religious congregation, was duly called and held in conformity with the aforesaid Article 10 of the Religious Corporation Law at 1454 East 14<sup>th</sup> Street, Brooklyn, NY 11230 on November 02, 2006 pursuant to notice given under the provision of Article 10 of the Religious Corporation Law. At such meeting, a majority of the qualified voters of said religious congregation, being at least six in number, were present, or by proxy duly authorized in writing.

**SECOND:** At said meeting, **SHLOMI DENAN**, one of the subscribers thereof, was the presiding officer and **SARAH DENAN**, **EVA STUHL**, **ELI DANAN**, **RIVKA DANAN** and **ABRAHAM HANUKA** were present and voted thereat.

**THIRD:** At said meeting, it was duly decided that the said Religious Congregation become incorporated.

**FOURTH:** The name of the proposed corporation as decided on at the said meeting is **Netzach Israel Zichron Aaron Inc.**

**FIFTH:** The principle objects and purposes for which the Corporation is formed are as follows:

- a) To conduct and maintain a House of Worship in accordance with the traditions of the Hebrew faith and to conduct all communal affairs necessary for a viable community.
- b) To purchase and sell property, both real and personal, to mortgage and lease

property, both real and personal, as may be necessary for the conduct and welfare of the corporation.

c) To publish memorial and religious texts.

**SIXTH:** The number of trustees shall be six (6).

**SEVENTH:** The Religious Corporation shall be located at 1454 East 14<sup>th</sup> Street, Brooklyn, NY 11230.

**EIGHTH:** The First Annual Election of the Trustees will be held on November 05, 2007. The election of Trustees thereafter shall be held annually, on the first Monday of November, commencing in the Year 2007 and the first Monday in November each and every year thereafter.

**NINTH:** The names and addresses of the trustees elected at the first meeting, and the Terms of Office for which they were respectively elected are as follows:

ABRAHAM HANUKA	100 Avis Avenue, Lakewood, NJ 08701

SHLOMI DENAN and SARAH DENAN shall serve until the First Annual Election of Trustees.

**TENTH:** Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1954 (the "IRC"), and shall not carry on any activities not permitted to be



carried on by a corporation exempt from Federal income tax under IRC Section 501(c)(3) or corresponding provisions of any subsequent Federal tax laws.

**ELEVENTH:** No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporation assets on dissolution of the corporation.

**TWELFTH:** No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC Section 501(h)), and the corporation shall not participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

**THIRTEENTH:** In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC Section 501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of New York.
