ADDENDUM TO

APPLICATION BY FOREIGN NOT FOR PROFIT CORPORATION FOR AUTHORIZATION TO CONDUCT ITS AFFAIRS IN FLORIDA

SECTION 8. (PURPOSE)

- 1. The purpose for which the Corporation is formed, and the business and objectives to be carried on and promoted by it are to operate a religious organization exempt from income taxation under Section 501(e)(3) of the Internal Revenue Code ("IRC").
- 2. Except as otherwise limited herein, the Corporation shall have all power necessary or convenient to effect or transact any or all of the business or purposes for which the Corporation is organized and shall likewise have all the powers provided by the Minnesota Nonprofit Corporations Act ("Act").
- The Corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the IRC. The Corporation shall not afford pecuniary gain, incidentally or otherwise, to its directors, officers or other private persons; no part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered. Notwithstanding any other provisions of this purpose statement, all of the work of this Corporation shall be carried on, and all funds of this Corporation, whether revenue or principal and whether acquired by gift or contribution or otherwise, shall be used exclusively for purposes and programs permitted by the Act, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for federal, state or local public office, unless otherwise permitted under the IRC, any future federal tax code and the Act. No substantial part of the activities of the Corporation shall be carrying on of propagands or otherwise attempting to influence legislation.
