To Whom It May Concern:

The University of Colorado was originally established as a territorial university by act of the Council and House of Representatives of the Colorado Territory on November 7, 1861. Upon Colorado's admission to the Union in 1876, the Constitution of the State of Colorado declared the territorial institution of the "University at Boulder" to be an institution of the state. As provided by the state constitution and state law, the Regents of the University of Colorado, duly elected, constitute a body corporate.

CONSTITUTION OF THE STATE OF COLORADO ARTICLE IX EDUCATION

Section 12. Regents of University

There shall be nine regents of the University of Colorado who shall be elected in the manner prescribed by law for terms of six years each. Said Regents shall constitute a body corporate to be known by the name and style of "The Regents of the University of Colorado". The board of regents shall select from among its members a chairman who shall conduct the meetings of the board and a vice-chairman who shall assume the duties of the chairman in case of his absence.
