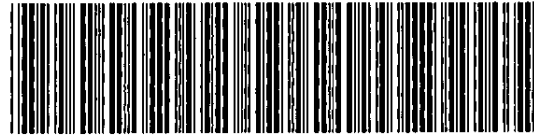

The purposes of the Marine Corps Veterans Association, Inc. (the "MCVA") to be carried out in the state of Florida are to aid and render assistance to all Marines and former Marines, their spouses, children, and dependents, and widows and orphans of deceased Marines and Corpsmen in the form of gifts to such persons of emergency funds for needs such as clothing, furnishings, housing, food or tuition. The MCVA will assist disabled and needy war veterans by providing to them gifts of wheelchair ramps, wheelchairs and gifts of money for the purchase of needed medical equipment. The MCVA will solicit the public for contributions to fund its programs and services that support the sending of civilian rations to the troops abroad by giving gifts of money to Operation Interdependence and similar organizations. The MCVA will provide entertainment, care and assistance to hospitalized Marines in the form of free subscriptions to Leatherneck magazine, gifts of television sets to military and veterans' hospitals and gifts of money to purchase restaurant dinners for patients and their families. Solicited contributions will be used to make gifts to pay costs associated with sending disabled veterans to the National Veterans Games, and encouraging activities that bring recognition to the Armed Forces. The MCVA will carry on programs to perpetuate the memory of deceased Marines such as participation in honor guard details at funeral ceremonies and participation in parades in honor of veterans and similar activities of a patriotic nature. The MCVA will provide social and recreational activities for its members, and contributions will be used to provide for the administrative operations of the MCVA. Contributions will also be used to provide gifts to support the Boy Scouts of America and other organizations as determined by the officers of the MCVA.
