

ARTICLES OF REDOMESTICATION OF ASCOT SURETY & CASUALTY COMPANY

ARTICLE I NAME

The corporation was originally incorporated in the State of South Dakota under the name Vanguard Life Insurance Company on February 19, 1971. On January 3, 2012, the corporation changed its name to Boston Indemnity Company, Inc. Upon the adoption of these articles, the name of the corporation will be changed to "Ascot Surety & Casualty Company."

ARTICLE II REGISTERED AGENT

The registered agent of the corporation shall be CT Corporation System located at 7700 East Arapahoe Road, Suite 220, Centennial, Colorado 80112.

ARTICLE III PRINCIPAL OFFICE

The principal office of the corporation shall be located at 10233 South Parker Road, Suite 300, Parker, Colorado 80134.

ARTICLE V CAPITAL

The amount of capital stock of the corporation is \$2,500,000 divided into 12,500 shares of common stock with a par value of \$200 per share, which shares shall have unlimited voting rights and are entitled to receive the net assets of the corporation upon dissolution. No other classes of shares are authorized to be issued by the corporation.

ARTICLE VI NUMBER OF DIRECTORS

The Board of Directors of the corporation shall consist of not less than three (3) and not more than twentyone (21) members.

These Articles of Redomestication shall be effective upon the filing with the Secretary of State of Colorado and, pursuant to C.R.S. § 7-111-108(9), upon the issuance of a Certificate of Redomestication by the Secretary of State of Colorado, shall constitute the articles of incorporation of the corporation. Upon the redomestication of the corporation, the corporation hereby accepts and will be subject to the laws of the State of Colorado.
