FIRST: The name of the surviving corporation is Dorma USA, Inc., a Delaware corporation, and the name of the corporations being merged into the surviving corporation are Rutherford Controls Int'l. Corp., a Virginia corporation, and Computerized Security Systems, Inc., a Michigan corporation (collectively, the "Constituent Corporations").
