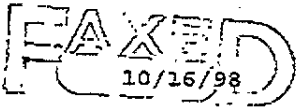

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, P.M.P. Investments, Inc., Corporation Number F12007, a corporation organized and existing under the laws of the State of Florida adopts the following Articles of Dissolution for the purposes of dissolving the Corporation:
