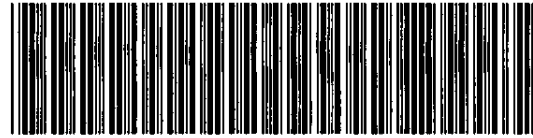

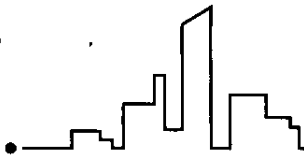

RE: Letter Addressing Start of Business Date

Dear Sir or Madam:

On September 29, 2012, Signal Point Corp. ("Signal Point") purchased substantially all the assets of RNK, Inc. ("RNK," together with Signal Point, the "Parties"), a Massachusetts corporation with authority to do business in Florida (Doc. No. F07000003873; FEI/EIN No. 043149565), pursuant to a September 28, 2012 bankruptcy court order, free and clear of any and all liens, claims, encumbrances and interests pursuant to Sections 363 and 365 of the Bankruptcy Code. The assets purchased by Signal Point included the employees of RNK, and certain real and personal property interests, such as certain accounts receivable, equipment, facilities, offices, contracts and customers.

RNK is also a registered Florida telecommunications provider. The sale of the regulated assets of RNK, such as its telecommunications licenses, is conditional upon approval of the appropriate regulatory agencies. Though RNK and Signal Point have filed a telecommunications license transfer application with the Florida Public Service Commission, the application is still pending and the licenses are still in the name of RNK.

Because Signal Point has not yet obtained authority to provide telecommunications services in Florida, in order to continue to provide such services the Parties entered a Management Agreement by which RNK, and by operation its licenses, are managed at the direction of Signal Point. This allows its Florida customers to continue to receive regulated services while the license transfer is pending.

While Signal Point understands that it will be responsible for any corporate taxes due from the September 29, 2012 business start date reported in its Application by Foreign Corporation for Authorization to Transact Business in Florida Form, it feels that any penalties it may be subject to for starting business prior to obtaining authority would be improper in light of the bankruptcy order and Management Agreement. There were certain uncertainties in the bankruptcy sale order, as to court approval, timing, the form and stipulations, attendant settlements, objections of creditors, etc., that made preparations of corporate filings for Signal Point difficult. Signal Point submits September 29, 2012 as its business start date in Florida because the unregulated assets of RNK were transferred to Signal Point on that date, but the transfer of the regulated assets of RNK in Florida has not yet been

consummated. RNK is still a licensed telecommunications provider in Florida with active corporate authority, and the Florida telecommunications licenses are still in the name of RNK. The regulated services are being provided in Florida under RNK's licenses at the direction of Signal Point. These factors create a grey area in terms of a business start date for Signal Point in Florida.

While Signal Point submits this date in the interest of obtaining corporate authority and as a basis to obtain RNK's telecommunications licenses, including the corporate tax liabilities that attach from this date, the uncertainties created by the bankruptcy sale and Management Agreement in terms of a definitive start date should not be used as a basis to impose a penalty or some other liability upon Signal Point for conducting business prematurely in Florida.
