

Community Shares of Minnesota operates as the Principal Combined Fund Organization (PCFO) for managing the Combined Federal Campaign (CFC) for the Northern Lights CFC which is the federal government charitable giving program. Its area encompasses Minnesota and parts of Wisconsin, Iowa, North Dakota, and South Dakota. CSMN manages the conduct of the campaign and ensures the collection and distribution of funds raised in the campaign to the designated charities. Community Shares of Minnesota was selected to perform this same function for the Suncoast CFC based in Tampa and surrounding counties in Florida. The day-to-day management of the campaign will be conducted by CSMN employees in Florida while the collection and distribution of funds will be handled by CSMN employees in St. Paul MN.


