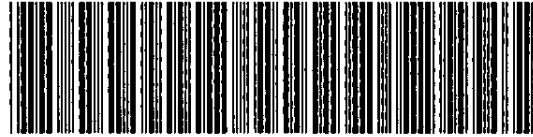

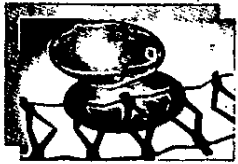

This is an oversight on our part as we have been registered with the Florida Department of Revenue and in compliance since 2002. Our FEIN is 73-1444023, we have filed the appropriate Tax forms each and every year we have been operational in Florida.

We have no physical locations, investments, real estate or offices set up in the state of Florida. We provide professional staffing services in the state of Florida from our corporate office in Oklahoma. The company changed ownership December 2008 and until recent due diligence was under the impression that we were registered appropriately with the Secretary of State.

I have enclosed the appropriate documentation and applications as well the filing and late fees. I was told by your office yesterday that the total amount was \$2087.50, a onetime \$500 penalty and \$150 dollars for every year we have been doing business (Since 2002) in the state of Florida, thus a sum of \$2000 plus the \$87.50 Filing fee and Cert status fee.
