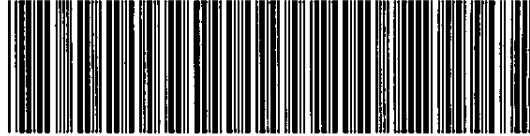


Brokers recently filed Articles of Amendment in PA in order to change its name to Global and, accordingly, would like to also change the name in Florida.


